Please note: for your vote to be counted, **you must also state the name and form of the pupil for whom you have parental responsibility**. This is simply to ensure the legitimacy of the voting process and the information will not be used for any other purpose.

Every adult with parental responsibility for a student currently on our roll is entitled to vote.

- Write '1' opposite the name of the candidate who is your first choice, '2' opposite the name of the candidate who is your second choice and so on.
- You can mark as many choices as you wish but you must number them in order.
- Do not mark your ballot paper with an ' $\times$ ' or a ' $\checkmark$ ' or any other mark or symbol.

- Place this ballot paper in an envelope, and seal it.
- You **MUST** also write the name and form of the child for whom you have parental responsibility on the outside of the envelope.
- Please return the envelope *via* your child, or by post, to Mrs S Deveney (Returning Officer), in school by **9am** on **Wednesday 17th October 2023**.

#### THE SINGLE TRANSFERABLE VOTE

The following both explains the mechanisms and philosophy behind the single transferable vote has been adapted from a paper by the Electoral Reform Ballot Services.

The STV is a system which is deemed to ensure that, as far as possible, every vote has a positive part in helping to elect a candidate, that no voting power is wasted, and that no voter has a greater influence on the result than any other.

The system gives each voter **ONE** vote and makes that vote transferable. Voting papers are completed by placing the candidates into a preferred order using the figure '1', '2', '3' etc. The figure '1' represents the vote and is mandatory. The rest are contingency markings and optional but important as they can influence the final result. For that reason the voter is recommended to express preferences until s/he is unable to differentiate between any remaining candidates.

When votes are counted, the Returning Officer works to a Quota. This is the number of votes a candidate requires to be certain of election and is calculated to a simple arithmetical formula (number of votes cast divided by 3, plus 1).

If a candidate has more votes than the quota, s/he is elected. If this does not happen immediately, the candidate with the least votes is eliminated, and their votes are transferred to other candidates (the voter's second or subsequent choices) – *ie* the contingency markings come into play. This avoids votes being wasted as would be the case in a first-past-the-post election.

Under no circumstances can a later preference count against an earlier preference.
